Whitestone Pond Consultation

The proposal to improve the Whitestone Pond (at the top of Hampstead) was discussed and it was agreed that the response should contain the following points:

- the Whitestone Milestone area should retain the ramps
- Whitestone Walk should be a shared pedestrians/cyclists way with no motorised vehicle access
- The new location of the bus stop should be clarified
- ASLs should be added on all sides of the West Heath Road and Heath Street junction
- Speed reduction measures should be introduced at the round about of Heath Street and Spaniard Road
- The scheme should also offer the opportunity to investigate an improved continuation of the cycle lane on Spaniard Road to a point opposite Whitestone Walk

### Regent's Park

We discussed the Royal Park (RPA) invitation to hold a publicity day to advertise the opening of the broadwalk to cycling. Many felt that an event that would bring many cyclists to the broadwalk on a specific day would be counterproductive to process of gently introducing cycling to regent's Park. Meade suggested, and it was agreed, that a good option would be for RPA to hold a cycle training day on the broadwalk. This would allow to advertise the opening of the broadwalk without attracting large number of cyclists at once. It would also give the positive image of enhancing responsible cycling in the park. **Stefano to ask Anne to write to RPA with this suggestion.**
