

Meeting between CCC and Camden Officers

24th June 2014, 10:30 - 12:30 am

Present: John Futchter (JF), Simi Shah (SS), George Coulouris (GC, Minutes), Jean Dollimore (JD), John Chamberlain (JC)

1. Actions outstanding from March meeting (*previous minutes in italic*):

1a. SE Corner Russell Square.

From Kevin 12/6/14: *We have recently submitted our modelling analysis for the South-East corner of Russell Square which would include an early cut-off phase, allowing cyclists to turn-right safely. This is currently with Transport for London for their review. Does this also include ii) the removal of one northbound vehicle lane. In either case, the means of approach for southbound cyclists needs to be designed?*

Camden are convinced of solution, will meet with TfL next Wednesday.

Action: Simi will give CC an update immediately after the meeting.

1b. Bartholomew Area Rat Runs

Date of Public meeting? **Action:** *CCC to contact Tom Platt.* Outstands.

Action: Simi is organising the meeting in the next 2 weeks. E.g. at St Luke's. She will contact resident associations. Consultation on September.

1c. Signage schedules John C. has sent the list for Camley St and several issues on the N-S and E-W routes to Dave Stewart. Dave will proceed to implementation as soon as effort available. **Action.** *JF to check with Dave Stewart.*

Action: Dave Stewart to progress.

1d. Quick Wins

Action: *Kevin De Leeuw to send progress list to CCC*

Action: *CCC to publish news item on website as soon as five or so have been put in place.*

Action: Kevin to send update (overview).

2. Measures in Kentish Town (excluding BART area anti-rat running)

We have seen TMOs for Kelly Street and Wolseley Mews: timescale?

Progress on other items e.g. Bart Rd bollards, Castlehaven - Anglers Lane signal, Wilkin Mews gate, and others.

Update: Bartholomew/KTR table implemented.

5. Royal College Street counter and extensions

CCC still has no access to the online counter data

Action: John to send us login details

update: we have logins, but the service provide seems to be claiming ownership of the data.

Hence we cannot implement the vision we discussed with daily updated counts on the CCC website.

Dates for consultations on extensions?

JC is concerned about short time for cycles in the signal at Camden Road.

Meeting felt there may be an error.

Action: Simi will take it up with Darren Barton and report

Action: Consultation on preparation. Will be put to ward councillors soon. Public consultations on both North and South extensions in September.

6. Tavistock Place/Torrington Place

JF will arrange a meeting in the summer to discuss survey results and possible approaches

Consultants are preparing a report on the effects of the recent temporary closure on traffic movements. Report due in August.

Further action: JF said the project will be picked up after a decision on WEP (October).

7. Delancey-Pratt

Timescales for crossing and for Parkway - Delancey junction

Large scale modelling of entire area is in hand.

JF: No funding yet, so no timescale. There is a serious lack of officer resources for implementing this and other schemes.

8. Cycle Parking

Footway parking: Angela Hobsbaum will organise street by street meetings with Kevin

JD: waiting for feedback on Camden High Street. JF: no room on Camden High Street North. On-street parking in side streets?

Carriageway parking: Action: Simi is proposing to review all the outstanding proposals for on-carriageway because the consultations are negative and old (!)

St Pancras Car Park: Action: Kevin to update

College Place Bikehangar approved last week **Action:** order to be placed

9. New LCDS documentation

Any ideas about how we could learn how to use it?

JD suggested a seminar. JF said a course from Brian Deegan has been organised (4 July 2-5 pm) and we shall be invited.

10. New projects coming up?

JF: N-S CSH. Camden say the roads proposed by TfL aren't wide enough. Camden/TfL meeting this week.

JF: CS11 - JD has details.
