3. Quarterly Meeting with Camden Officers, London Living Streets and Cllr Fulbrook

4. Safe and Healthy Streets Decisions

Camden Square - The officer's report had been published and the scheme was approved by Councillor Harrison. CCC had sent in a number of suggestions, most of which had been rejected though Camden had responded. CCC had asked for a meeting to discuss our concerns and will press for this; there is still time for minor changes. RW said that many of the changes (such as the replacement of the diagonal closure on Murray Street) had been suggested by residents early in the consultation process before they had become used to the new road layouts and it would have been better if Camden had waited. The proposals and CCC's response are here.

Phoenix Road - This has also been approved; it is mostly a streetscaping scheme but motor traffic will be reduced. EM said that the consultation process was much too complicated and that

Westminster had a simpler one; SP said that Camden were very careful to address people's concerns. Details here.
