# Background & Purpose

## What is the Project Framework?

The Project Framework has been developed from the ideas suggested during engagement is summer 2025. We've also added projects from Camden services and partners so that all projects, including the ones that are planned or already underway, for Camden Town have been brought together in one place.

Having them all in one place means we can share the Project Framework with people who live in, work in and visit Camden Town. This allows us to understand how all the projects and project ideas work together, so that we can coordinate and collaborate for the benefit of Camden Town and its communities as a whole.

Through the consultation, where we will be asking you which project ideas you want us to prioritise, we will be able to start working together to develop and deliver some of the project ideas too. It is an exciting opportunity to build on what is happening already and help shape the future of Camden Town.

Given the challenging financial environment, the Project Framework also allows us to work with existing funding streams such as S106 Contributions and the Community Infrastructure Levy. The Project Framework can play a significant role in identifying gaps in resourcing too. It can bring together public and private sectors to unlock funding and support the development and delivery of projects that meet the Vision's aspirations.

The Project Framework is not intended to be a static document but will provide a framework and focus for the delivery of projects that will meet the Camden Town Vision's aspirations - putting the Vision into action.

## Why have we developed it?

Given the significance of Camden Town, we think it is important to produce a comprehensive delivery plan for Camden Town. This will help us guide investment to meet the aspirations of the Camden Town Vision. We have been working with key Council services and stakeholders to make sure the Project Framework is a complete picture of what is happening in Camden Town.

## How will it be used?

The Vision's success will depend on genuine collaboration, partnership working, joined-up planning, community participation, and transparent delivery. We believe that this is an opportunity to address the issues that are facing Camden Town, and leverage its opportunities. Once this document evolves into a Delivery Plan, it will also be used to monitor the delivery of the strategic Vision for Camden Town.

## How does it relate to the themes and aspirations of the Camden Town Vision?

Camden Town is a complex place, and the Vision covers a wide area with variety of communities, built form and functions. The Project Framework sets out a list of projects by theme and defines the projects we may want to include in the Delivery Plan. The area-based maps in the draft Vision document highlight the relevant projects in those areas and the delivery section highlights the priority projects. Both of these are included under the relevant theme in this document.

Working collaboratively to refine the Project Framework is key. For the project ideas, we have included a list of potential

## Guidance for delivery

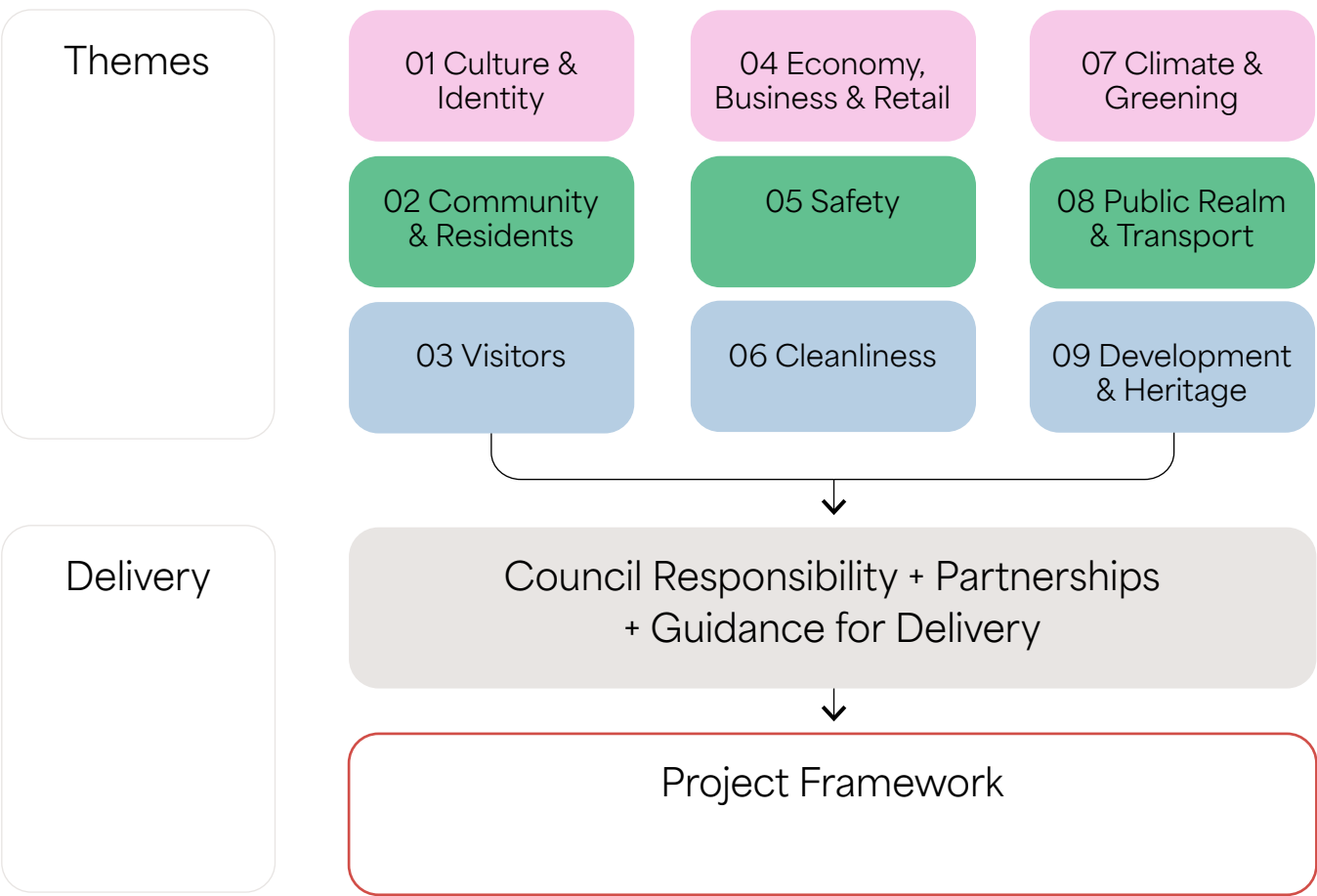
